

### REGULAR MEETING

The Regular Meeting of the Hogansville City Council was held on Monday, April 15, 2019. The meeting was called to order by Mayor Stankiewicz at 7p.m.

Present were Mayor Stankiewicz; Council Member Reginald Jackson; Council Member Marichal Price, arriving a little late; Council Member Fred Higgins; Council Member George Bailey; and Council Member Theresa Strickland. Also present were City Manager David Milliron, City Clerk Lisa Kelly, and Chief of Police Brian Harr. Council Member Bailey gave the invocation and Mayor Stankiewicz led the pledge.

Motion by Council Member Bailey to approve the agenda amending to add Willie Cameron as #1 under Citizen Appearances and #4 under New Business, Resolution for USDA Rural Business Development Grant. The motion was seconded by Council Member Higgins and carried 4-0.

Motion by Council Member Strickland to approve the minutes of the Work Session held on April 1, 2019, seconded by Council Member Jackson. Carried 4-0

Council Member Strickland asked the that the record reflect, under New Business #3, Bid Acceptance for Architectural Drawings - 111 High Street, the \$20k bid amount will not be paid from City funds but from three other potential sources. Motion by Jackson to approve as amended, seconded by Bailey. Carried 4-0

- Elite Basketball Camp Mr. Tommy Jenkins. Mr. Jenkins thanked the Mayor & Council for their support over the years to Elite Basketball Camp. He announced this year's camp will be held on June 15<sup>th</sup> at Hogansville Elementary School for youth ages 5-14.

Mr. Prophet addressed the Mayor & Council introducing himself as the new director for the Boys & Girls Club of West Georgia and announced Faith and Family night will be held on May 2nd. Several topics will be discussed targeting the community to include building bonds will local teens. The annual Boys & Girls Club dinner will be held in LaGrange with a guest speaker on May 8th.

1. Mr. Willie Cameron to discuss sidewalks. Mr. Cameron expressed the need for sidewalks and asked if grants can be utilized to get funding. He is concerned that the same sidewalk needs were being discussed 39 years ago and asked if Citizens can apply for grants. He specifically would like to see sidewalks in the areas near the Splashpad and down Boyd Road to Head Homes.

Resolution - USDA I Rural Business Development Grant. Motion by Strickland to approve the
resolution authorizing application submission for a USDA Rural Business Development Grant for
\$200k to be used for the Royal Theater project, utilizing SPLOST dollars as the local match;
seconded by Bailey. Carried 4-0, with no vote by Higgins.
