BACKGROUND (Includes description, background, and justification)

Chris Tucker's five-year term on the LaGrange-Calloway Airport Authority is up for reappointment. Mr. Tucker would like to be appointed to a new 5-year term. On November 19, 2018, the City advertised this opening on its website and via utility mailers. Four outside applicants stepped forward: Alan Jones, Richard Money, Brandon Rettke and Richard Woods. All five applications (from Mr. Tucker and the 4 outside applicants) are attached.

The LaGrange-Calloway Airport Authority is asking the Hogansville City Council to reappoint Mr. Tucker, or to appoint someone else, to the Airport Authority for a five-year term that will expire June 30, 2024.
