



TECHNOLOGY TO TRACK YOUR CASE LOADS

From face-to-face supervision to employing the latest technology, PPS tracks your offenders 24 hours a day, seven days a week.

- Basic Supervision Offenders are seen once monthly at any of our locations to make payments and complete
 special conditions.
- Intensive Supervision Offenders are visited in the field at least once monthly, while also reporting to an office location weekly for random drug screenings.
- Pre-Trial Supervision (Diversion) Non-violent defendants awaiting trial can be supervised subject to conditions.
- GPS Monitoring Utilizing global positioning satellite technology and transdermal alcohol testing technology, daily reports are submitted to your court detailing offender activities and location in real time.
- Integrated Voice Recognition Our voice recognition tracking and voice recording eliminate false violations and increase system credibility.
- Anklet Monitoring and Breath Alcohol Testing This house arrest system enforces curfews and detects
 substance abuse by employing the latest technology in both anklet and breath test monitoring. Defendants
 may not be farther than 150 feet away from their home.

The PPS Family of Companies is honored to submit this <u>letter of interest</u> to the City of Hogansville, and sincerely hope to be able to serve the city's court, community and offenders. PPS submits this letter and intends to provide services to the City of Hogansville through our wholly owned subsidiary, Judicial Correction Services, LLC.

PPS is a Georgia Corporation. Clay Cox is the Founder and Chief Executive Officer. Additional corporate officers include C. Keith Ward, Vice President; Donna Kennedy, Secretary; and Tom York, Esq., Vice President and Corporate Counsel. PPS and its subsidiaries, Judicial Correction Services, LLC (JCS), Georgia Probation Management, Inc. and Northeast Georgia Probation, Inc. are registered and are in good standing with the regulatory bodies in the states that we operate, including Georgia's Department of Community Supervision.

PPS operates more than 60 locations in five states. Our nearest location to Hogansville is currently our JCS Troup County location at 209 Ridley Avenue, Lagrange, GA 30240. We also operate offices in nearby Peachtree City, Union City and Douglasville to name a few. Each of our locations are open on Saturdays, evenings as well as normal business hours.

Recognizing that the government approach to probation supervision was in many ways flawed, mainly due to a lack of resources, we created a business and supervision model expressly designed to promote offender success while on probation and beyond. The first court to agree with our new approach- and to take a chance on PPS was Norcross Municipal Court, for which we began providing services on *September 1*, *1992* and still serve today!

JCS was formed to solve problems identified in existing probation systems including:

- Lack of focus on motivating probationers to complete probation
- Poor or lax management
- Lack of company focus exclusively on probation
- Poor use of technology
- Lack of transparency in recordkeeping
- Probation companies collecting their money before the Courts'.
- Levy of multiple social programs siphoning money from fine collection.









JCS built a company ethical code to correct these industry problems by:

- JCS employees to be provided incentives to manage probationers to complete probation.
- PPS keeps the management of misdemeanor probation as its core and only business.
- JCS developed *ProbationTracker* TM the first online probation management tool in the industry and offered it to all its customers at no cost.
- JCS made all its customer records transparent, up-to-date, and available 24/7.
- PPS contractually agrees to collect the majority of the fines, victim restitution, and court costs, before probation fees.

Our ethical code, combined with a business philosophy of promoting offender success has proven enormously popular with judges, court clerks and governing authorities.

A History of Success

JCS was founded by people working in the probation field who recognized the need for change. We recognized, for example, that technology was being underutilized in the case management of probation cases. Officers were spending three quarters of their time typing warrants or court paperwork and not spending nearly enough time with the probationers who needed them. The system was failing and probation became a problem rather than a solution. JCS was and is the solution. From one small office in 1992, we have grown to serve more than 100 courts and 55,000 probationers each month. That being said, we realize that we must not fall into the same trappings of our predecessors and we must continue to improve and innovate.

The company that started in 1992 is not the same one that submits this proposal today. Our services, technology, knowledge, and footprint have grown immensely over the past twenty-five years. Continual advancements in probationer and pretrial supervision combined with customization of services and technology to fit the needs of local courts is what sets JCS apart. This is what our 300+ employees persistently work to continue providing to the courts we serve.

Successful Supervision. JCS has successfully supervised over 700,000 probation cases in the last twenty-five years.

Dedication to our Clients. JCS will contractually agree to collect court monies at a percentage greater than our own. We will also agree not to collect any JCS monies until all victim restitution is paid in full each month.

ProbationTrackerTM. JCS's Offender Tracking System, ProbationTrackerTM is our comprehensive case management system that makes case administration swift, simple, and accurate. It frees our employees to spend more time face to face with probationers without sacrificing the quality of their paperwork or documentation. The extra "face time" our system frees up leads to a much greater successful termination rate.

Transparency with the Courts. JCS provides authorized court personnel with 24/7 access to all probation files. Files are accessible from any computer with internet access and show information such as money collected and applied, class progress, and appointment notes in real time.

Bilingual Capabilities. We will ensure that all non-English speakers understand what is expected of them and provide important documents in Spanish. We also have at least one bi-lingual officer available on staff as needed.

Field Offices- Case Transfer Capabilities. JCS will open a full-time location in Putnam County, and JCS offenders can transfer their case and report to any of our 60+ locations. We are open early and into the evenings on various days Monday – Friday. We are also open on Saturdays so that folks don't miss work to report to our offices.

Anger Management	\$25.00 per book and \$200.00 total for the class

	Trans-dermal Alcohol Monitoring (\$12.00 per day + \$50.00 Activation Fee) The defendant's alcohol consumption is monitored 24/7 through a cellular receiver.
Five (5) Panel Drug Test	\$20.00 per Test
ETG Alcohol Test	\$35.00 per Test
