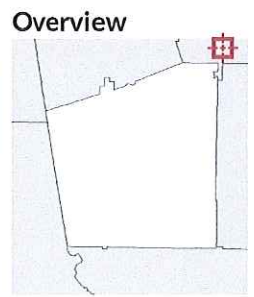
**BACKGROUND** (Includes description, background, and justification)
