Regular Meeting - 7pm

CONSENT AGENDA

NEW BUSINESS

1. Bid Acceptance - Tower Trail V

Motion: Motion was made by Council Member Neese to accept the bid from Piedmont paving in the amount of \$357,614 for construction of Tower Trail Phase V. The motion was seconded by Council Member Striblin.

2. SPLOST Expenditure - Tower Trail V

Motion: Motion by Council Member Neese to approve an expenditure in the amount of not-to-exceed \$138,614 for the City's match portion of Tower Trail V construction from the SPLOST Parks & Recreation project fund. The motion was seconded by Council Member Price

Discussion: Total expenditure for this project is \$357,614, of which, \$200k is in grant funding, \$15k will be funded through Hogansville Charitable Trust, \$4k from Hogansville Downtown Development Authority, and remaining not-to-exceed amount of \$138,614 to be funded from SPLOST Parks & Recreation dollars.

Motion Passes 5-0

3. SPLOST Expenditure - Lake Jimmy Jackson

Motion: Motion was made by Council Member Neese to approve an expenditure from the Parks & Recreation SPLOST project fund in the amount of not-to-exceed \$95k for installation of three pavilions at Lake Jimmy Jackson. The motion was seconded by Council Member Ayers.

Roll Call Vote: Jackson(abstain), Price(Yea), Neese(Yea), Ayers(Yea), Striblin(Yea)

Motion Passes 4-0 with Jackson recusing himself

4. Lake Jimmy Jackson - Volleyball Court

Motion: Council Member Neese moved to approve installation, by the Pioneer Group, of a beach-type volleyball court at Lake Jimmy Jackson at no expense to the City. The motion was seconded by Council Member Price.

Roll Call Vote: Price (Yea), Neese (Yea), Ayers (Yea), Striblin (Yea), Jackson (abstain)

Motion Passes 4-0 with Jackson recusing himself.

EXECUTIVE SESSION

1. Personnel Exemption

Motion: Council Member Neese moved that the City Council go into Executive Session at 7:28pm under the personnel exemption. The motion was seconded by Council Member Jackson.
